## THE FUND

THE Austin's Charitable Fund has been established by the Austin Family in partnership with the Hertfordshire Community Foundation, to support and benefit the local community.

EVERY year a local charity is selected by the Austin Family, as the beneficiary of the Fund. Occasionally it may be decided to support more than one charity in a particular year.

A wide range of causes can benefit, with the primary focus on meeting social needs, such as:

- ☆ Providing activities and opportunities for young people
- ☆ Improving access to education, training and employment
- ☆ The quality of life of older people

DETAILS of the current annual charity are available from any Austin's branch, or Harwood Park Crematorium.

EACH year the company donates a proportion of its annual profits to the Fund. In addition, money is raised during the year from events such as the Harwood Park Memorial Service and Christmas Carol Services.
